Feedback from MCC (Mike Moran)	<ul> <li>Letters (emails) had now gone out from MCC to the organisations that had expressed an interest in seeking a Community Asset Transfer (CAT) of the 3 Fields site. The email stated that, 'none of the proposals were able to fully meet the Councils aspirations for the site and therefore concluded that they were not able to proceed with any of the applications. MCC remained fully committed to the delivery of a community facility and were keen to continue to involve community stakeholders in the project. They were currently considering options and would advise further in due course.'</li> <li>The article, by MCC about the 3 Field site, had been submitted to the Villager and would be delivered to residents very soon. Paul Turner would replicate the text on the website as soon as the Villager had been received by residents.</li> <li>Mike Moran had given further consideration to design and architects and had been in contact with 'Alliance Leisure' who could possibly advise with a design brief. Mike would also arrange some site visits to similar halls and centres in (e.g. Llanfoist) and possibly outside of Monmouthshire to get ideas on design and operation.</li> <li>Mike Moran would be putting a paper to MCC cabinet (1/3/17) seeking approval on the way forward for the three-field site.
